# #SkodaDriveOfBelief - Contest Terms & Conditions

### About the Contest:

The following terms and conditions govern the conduct of the contest ("Contest") which are organised by Škoda Auto Volkswagen India Pvt. Ltd. ("SAVWIPL").

By participating in the Contest, each entrant fully and unconditionally agrees to accept these terms and conditions specified as herein below.

## **Contest Duration:**

The Contest start from June 03, 2024 at 12:00 PM and end at 11:59 PM on June 19, 2024 IST ("Indian Standard Time") ("Contest Duration"). However, SAVWIPL reserves the right to extend or shorten the Duration of the Contests at its sole discretion.

### **Definitions**

- a. "Contest" means the contest titled as "Škoda Drive of Belief Contest"
- b. "Contestant" means the Indian citizen residing in India and following the Instagram Channel or Twitter Profile or Facebook Page of Škoda Auto India or Instagram channel of Fans of Škoda or X (Twitter) channel of Škoda India PR, who is eligible and chooses to participate in the Contest
- c. "Judge" or "Judges" means the Judge or the panel of judges appointed by SAVWIPL in its sole discretion, who shall have final authority to declare the winners of the Contests. The decision of Judge shall be final and binding on the Contestant.
- d. "Prize" means the prize declared for Winner (defined below) of the Contest by SAVWIPL.

  - b. Contestant must fill in the form on the campaign website and share their entry there.

# Participation Fees:

No subscription to SAVWIPL or purchase or payment of any fee is required for participating in the Contest. The participation is voluntary.

# Prize:

- 1. The Winner(/s) shall be declared as per the below criteria and are eligible for the prize(/s) accordingly:
  - a. 24 participants will be declared as winners on the basis of the lucky draw after first level of verification of the users' entry conducted by internal jury.
  - b. The winners will be eligible for a Škoda merchandise box and will be invited for a Škoda Drive Experience and a chance to meet the Škoda Auto India's leadership. The

- Additional Travelling and Lodging expense will be borne by Winner itself
- This Contest will be open for the Contest Duration communicated in the Contest requirements in India only.
- Participation subject to the respective state law. In case any contravention to the state laws the candidature of the participants shall deem to be void.
- Entries submitted in any manner other than specified in the Contest requirements will be automatically disqualified.
